Terms of Meal (Board) Agreement

- A. Eligibility: The applicant must be a currently enrolled student. Students who race ired to reside on campus (students under 21 years of a weight less than 60 UCM accepted credit hours who have not lived on campus for 2 years) are required to be on one of the designated meatlans for the entire academic year. Wo i vi aculty and staff are able to purchase dining dollars.
- B. Terms of agreement: This agreemest for the entire academic year, both fall and spring semesters. The residential dining centers are closed during semester breaks and holidays. There will also be limited-service hours in the Union during semester breaks and holidays. Any semester additions added to and billed with your semester plan. Students who wish to change their meabalands by August 23, 2024 for the fall semester or by Januarly7, 2025 for the springsemester. Meal plan changes can be made the Office of University Housing, Ellis Complex or on MyCentral.
- C. Rates: The cosisted is a per semester price. Students will be automatidailled at the beginning of each semester. Purchases matter August 23, 2024 for the fall semester and January 17, 2025 for the springsemester must be paid for at the times the purchase.
- D. Diningdollars and meals: Unused dining dollars n be carried from semesters semesters long the student is continuously enrolled in university. There is no refund of funds the dining dollars account. Meals purchased for a particular semester can only be used during that particular semester. Remaining and guest passes do not carry forward and are nonrefundable.
- E. Access Plan restriction: Tlaccess Plans for the use of the plan holder only. Access to dimeing hall is not transferable under any circumstances.

- G. Withdrawal from the university: If the student aves the university during the term of this greement, the student agrees to pay for attleals served and dining dollars used to the time of checking out of he halls or the daily rate, whichever is greaterplus 10% of the student's remaining all plan and add-on value for the semestern which the withdrawal occurs.
- H. Cancellation by student remaining at the university:
 - Students who are not required to have a meal planay cancel this greement in writing for the spring semester bleember 13, 2024 with no penalty. Cancellations by students who are enrolled will not be allowed after this date.
 - Students who are required to have a meal plare not able to cancetheir meal plaragreement unless they cancetheir housing agreement according to the terms in the sing agreement.
 - Students who cance their housing according to the terms of the housing agreement may also cancel their mealplan if they agree to pay for meals served up to chancellation date, or the aily rate, whichever is greaterplus 10% of the student's food service rate for the remaind academic year.
- I. Terminationfor violation of university regulation: The student herby consents and agrees to the right of the university to terminate this agreement for breach of university policies regulations concerning behavior while iresidence halls after the student exercises his/her right to due process contained in the current edition of the University of Central/lissouri Guide to Good Decision-Making.
